

# 2018 Skunk Works® Golf League

## Rancho Vista and Antelope Valley Country Club

The 2018 Skunk Works® Golf League will begin on Tuesday, March 27, 2018. It will last approximately 26 weeks. The league will play on Tuesday's and Wednesday's and will alternate week play between Rancho Vista G. C. and the Antelope Valley C. C.. There is room for a maximum of 24 teams (48 players) and an unlimited number of substitutes. The format will be two-man teams. A non-refundable fee of \$60 per player is necessary to secure your spot in the league. The fees will cover closest to the pin on each par 3 throughout the season, prizes for mini tournaments, administrative costs, trophies, and the awards luncheon. Although substitutes need not pay the \$60 entry fee, they are required to fill out this application.

Employees and retirees, as well as their insured spouses, sons or daughters (with parents' consent if minor) are eligible to participate. In addition, Contractors and Customers working with Lockheed Martin are also eligible. If you have any scheduling conflicts with playing Tuesday and Wednesday each week you must indicate this concern at the time of sign up. Efforts will be made (but not guaranteed) to accommodate any schedule conflicts.
